GENERAL TERMS & CONDITIONS

- The tender duly completed and signed shall be submitted in a sealed cover. The sealed cover upper-scribed "Tender for Refilling of commercial gas cylinders" shall be addressed to the Procurement office, GMC Baramulla and shall be submitted on or before 11-11-2025 10:00 AM.
- 2. The Tender should be accompanied with Earnest Money Deposit (EMD) of Rs. 50,000/- (Fifty Thousand only) in the shape of FDR/CDR of any nationalized Bank drawn in favor of Chief Accounts Officer GMC Baramulla.
- 3. The bidder shall have to deposit the EMD in the form of CDR/FDR only.
- 4. The intending bidders shall have to paste transparent tape on the rates quoted by them in Indian Rupees (INR) only both in figures and in words FOR, inclusive of supply (loading/unloading) and all taxes.
- 5. The Tender submitted shall remain valid up to 15th of March, 2026 from the date contract awarded.
- 6. The discount on the current Company Price list offered by the bidder will remain valid for supply and refilling of commercial gas cylinders till 15th March, 2026.
- 7. The successful bidder shall ensure that adequate advance stock of filled commercial gas cylinders is maintained at the hospital store at all time to meet any emergent or unforeseen requirement. The supplier shall be responsible for ensuring an uninterrupted supply of LPG cylinders throughout the contract period.
- 8. The billing process shall be initiated only after successful delivery and satisfactory inspection of the supplied/ refilled gas cylinders by the designated committee or authorized officer of GMC Baramulla. Payments will be released after due verification of quality, quantity, and adherence to the contractual terms and conditions.
- 9. The Tender inviting authority reserves the right to reject or accept any Proposal without assigning any reason or cancel or withdraw the tender.
- 10. If the supply of the required items is not affected before the specified period, the Institute shall have the authority to cancel the order or to take any action deemed fit in the circumstances.
- 11. In case of any dispute the jurisdiction will be courts at Baramulla only.
- 12. Tenders received after due date shall not be entertained.
